27 contact Warren Paboojian, Esq. regarding the ex parte hearing.


28 3. On May 22, 2000, at or around 4:28 p.m., I contacted Mr.

5 for such a purpose. I explained the basis for the order. I also advised
6 him that I was on calendar for Wednesday at 2:00 p.m. He checked his
7 calendar and advised that the time and date were available to him. I
8 explained that I needed to contact him before 10:00 a.m. on Tuesday.
9 And, although my papers were not yet drafted, I would like him to have a
10 full copy for his review prior to the hearing. I asked how best to present
11 the papers by hand or fax. He said he would like both to confirm that he
12 got the paperwork.
